This RFP is being issued by the Director Transport, U.T- cum - Divisional Manager, CTU, Chandigarh for inviting e-tenders for **“E-TENDER FOR SUPPLY, INSTALLATION, TESTING & COMMISSIONING OF IP HD FIXED DAY/NIGHT IR CAMERA INCLUDING COMPREHENSIVE MAINTENANCE CONTRACT (CMC) FOR FIVE YEARS FOR CTU PREMISES/ISBTS, CHANDIGARH.”** (herein after called “CCTV Cameras”) on such terms and conditions and technical specifications as set out in this RFP document.

It is hereby clarified that this RFP is not an agreement and is not an offer or invitation by Chandigarh Transport undertaking to any party hereunder. The purpose of this RFP is to provide the bidder(s) with information to assist in the formulation of their proposal submission. This RFP document does not purport to contain all the information bidder may require. This RFP document may not be appropriate for all the persons, and it is not possible for Chandigarh Transport Undertaking to consider particular needs of each bidder. Each bidder should conduct its own investigation and analysis, and should check the accuracy, reliability and completeness of the information in this RFP document and obtain independent advice from appropriate sources. Chandigarh Transport Undertaking and their advisors make no representation or warranty and shall incur no liability financial or otherwise under any law, statute, rules or regulations or otherwise as to the accuracy, reliability or completeness of the RFP document.

Chandigarh Transport Undertaking may in their absolute discretion, but without being under any obligation to do so, update, amend or supplement information in this RFP document, as required from time to time.

## 1. **Scope of work:-**

The scope of work to be undertaken by the successful bidder as mentioned in the RFP/tender document and in compliance with the technical specification and Bill of Quantity. The scope of work includes supplying, installation, testing, commissioning of CCTV cameras, Network Video Recorders, switches, POE cable, power cable, poles for mounting CCTV cameras, Racks, Mounting brackets, PVC conduit/G.I. piping for laying cables etc. or any work associated thereto. The works includes design and execute an IP network based surveillance system and provide turn-key solution for the entire project. IP Dome and Bullet Cameras are required to be installed at various locations as per the requirement of Chandigarh Transport Undertaking (CTU) at ISBT-17, ISBT-43 or Depot's of CTU and to make system functional complete in all respect. Digging/Boring, filling of earth, Chipping of walls and ensuring to make the site to its original condition shall be the responsibility of the successful bidder including supply and installation of poles, housing & any additional fixtures. The work should be state of art and to be done in neat and clean manner. The successful bidder shall be responsible for restoring the area to its original shape wherever, the digging has been undertaken by him for end to end implementation of the system. The work includes complete equipments and required accessories along with necessary power systems including standard Uninterrupted Power Supply for the entire equipments, video connectors, patch connectors, patch cord, mounting and fitting hardware, plugs, sockets and any hardware/software, etc. as required for complete installation of the System. Electrical cabling upto the equipment at each location shall be the responsibility of the successful bidder. All Electrical cabling shall be done through HDPE/PVC conduit pipe/GI pipe and upto equipment at each location shall be in scope of successful bidder as per site requirement. The configuring of equipments is also in the scope of successful bidder. However, power supply to the UPS including cabling, space for installation of equipments shall be provided by CTU. **The minimum suggestive technical specifications and Bill of Material is given as per Annexure 'A1'.**

## 2 **QUALIFICATION CRITERIA**

### 2.1 **TECHNICAL QUALIFICATION CRITERIA:-**

- i) The prospective bidder must be either OEM itself OR Authorized Distributor/Dealer of approved makes of CCTV, NVR & Switches as mentioned in annexure-'A1'. The documentary proof must be attached along with technical bid.
- ii) Experience of similar nature of 2 (two) project of minimum value of 10 lac each in last three years as on 31.03.2018 consisting at least 50 IP CCTV Cameras for each project in Government sector or Private sector (Fixed/Dome/PTZ etc.). Satisfactory performance/completion certificate and purchase orders duly notarized must be attached along with the technical bid.
- iii) The prospective bidder must have Registered service tax number/GST should be attached with the technical bid.

### 2.2 **FINANCIAL QUALIFICATION CRITERIA:**

- i) The bidder should have average annual turnover of Rs. 40.00 Lakh (Rupees Forty Lakh only) for the last three years ending on 31.3.2018 duly attested/audited by Chartered Accountant (CA). The bidder has to submit its documentary proof for the same.
- ii) The bidder must attach Income Tax clearance certificates for last three years ending on 31.03.18.

## 3 **Documents comprising Bid:-**

1. Complete documents in support of Technical qualification criteria as defined above consisting completion Certificate, performance certificate, detailed work order etc in respect of completed projects and OEM or authorized dealer/distributor certificate.

2. Complete documents in support of financial qualification as defined above.
3. The bidder(s) should furnish the copy of PAN Card and GST registration certificate.
4. Scanned copy of the EMD as well as the tender documents/RFP duly signed each page must be attached with the technical bid online and the original should be deposited in physical form in the office of the Director Transport, UT, Chandigarh on or before the closing date of the bid.
5. Scanned copy of the affidavit (as per specimen given in the tender documents) must be attached with the technical bid online and CTU may ask for the original if required.

#### **4 EARNEST MONEY DEPOSIT (EMD)/BID SECURITY.**

- 4.1 The prospective bidders shall submit Earnest Money Deposit (EMD) amounting to **Rs.1,00,000/- (Rupees: One lakh only)** in the shape of Bank Draft/FDR/Bank Guarantee in physical form of any scheduled Bank in favour of Divisional Manager CTU & Director Transport UT Chandigarh, Plot No. 701, Industrial Area Phase-I, Chandigarh, payable at Chandigarh and scanned copy of the same must be submitted along with the technical bid online.
- 4.2 The EMD of the unsuccessful bidder will be returned immediately after the allotment of the said contract and the EMD of the successful bidder will be returned after depositing the performance security and signing of agreement as per tender documents.
- 4.3 The e-tender must be accompanied with Earnest Money Deposit (EMD) for the amount as mentioned and drawn in the name of the Divisional Manager CTU & Director Transport, U.T., Chandigarh, Plot No. 701, Industrial Area, Phase I, Chandigarh, payable at Chandigarh which should be valid for 180 days beyond the opening of technical bid.
- 4.4 In case of successful bidders backs out, his/her earnest money/security shall be forfeited along with interest thereupon and the bidder will be black listed for any future contract as per Chandigarh Administration Finance Department Notification No. 1927-F&PO(3)-2009/1170, dated 27.02.2009.
- 4.5 No bidder is exempted from furnishing the Earnest Money Deposit (EMD) under any circumstances.

#### **5 SUBMISSION OF BIDS**

- 5.1 Bidders shall have to submit technical and financial bid Online only and EMD is to be deposited physically before due date and time of the e-tender.
- 5.2 Technical bid shall consist of the documents as mentioned in clause no 3 above and any other documents as well as the technical and commercial information required in accordance with the tender document.
- 5.3 Financial Bid shall contain the price bid only.

#### **6 Financial BID:-**

- i) The bidder (s) should submit their price bid/commercial bid online only as per the BOQ to the tender documents available on the e-tender website for complete job (Supply, Installation, Testing & Commissioning of IP HD fixed day/night IR Camera) along with Comprehensive Maintenance Contract (CMC) for a period of five years excluding all taxes.
- ii) The taxes will be paid as applicable on actual date of payment.
- iii) The Price Bid will only be opened of those bidders who technically qualify in the evaluation of their technical bids. For opening Price Bid, time and date will be intimated separately.

## **7 EVALUATION AND COMPARISON OF BIDS**

The Department will evaluate and compare only those bids which are determined to be responsive to the requirements of this bid Document.

## **8 AWARD OF CONTRACT: AWARD CRITERIA**

**The Contract will be awarded to the bidder in whose Total Bid Price will be lowest as per financial bid/BOQ (excluding all taxes/GST), provided bidder fulfills all other terms and conditions of the tender documents.**

## **9 TIME PERIOD FOR THE COMPLETION OF WORK:**

The work for the supply, installation, testing and commissioning (complete job) should be completed within one month from the date of the Letter of Award (LOA)/work order.

## **10 DEPARTMENT RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL BIDS**

The Department reserves the right to accept or reject any Bid, and to annul the Bid Process and reject all Bids without assigning any reason.

## **11 PERFORMANCE SECURITY-**

11.1 The successful bidder will have to deposit performance security @10% of the total cost of the Project in the form of Fixed Deposited Receipt (FDR) or a Bank Guarantee from a commercial bank in favour of "The Divisional Manager, CTU & Director Transport U.T., Chandigarh" payable at Chandigarh, which should be valid for a period of 66 months from the date of supply order/Letter of Award (LOA) and shall have to be deposited and signing the agreement on the non judicial stamp paper of Rs.100/- within 15 days from the date of issue of the Letter of Award/Supply Order.

11.2 In case of delay in performance security up to 30 days from prescribed time limit, penalty as per penalty clauses shall be imposed. In case of further delay CTU will be at liberty to forfeit EMD so deposited.

11.3 In case of violation of any of terms and conditions as mentioned in the tender documents, the performance security of the bidder(s) shall be forfeited in full along with interest thereupon and the bidder will also be black listed for any future contract as per Chandigarh Administration Finance Department Notification No. 1927-F&PO(3)-2009/1170, dated 27.02.2009 by the Director Transport, U.T., Plot No. 701, Industrial Area, Phase 1, Chandigarh.

## **12 TERMS OF PAYMENT:-**

### **Total bid price means that**

**75% CAPEX COST**

**25% OPEX COST/CMC COST**

**100% TOTAL BID/UNIT PRICE INCLUDING CMC cost.**

- (i) After satisfactory installation of complete Equipment & accessories as mentioned in schedule of quantities : **70% of CAPEX cost.**
- (ii) After successful functioning of the project in : **30% of CAPEX cost**  
the CTU premises and report of the General Manager/Incharge of the depot/unit concern/  
Satisfactory report of the inspection committee.

- (iii) The comprehensive maintenance cost (OPEX) shall be paid 06% of total bid price for every year. For getting the Opex/maintenance/CMC payment, the successful bidder shall submit the bills on 7<sup>th</sup> day of every next year. On receipt of the bill the Department shall release payment to the successful bidder subject to recoveries, if any, within 30 days.

### **13. COMPREHENSIVE MAINTENANCE CONTRACT**

- (i) The successful bidder is liable to maintain the complete system in functioning condition at all time i.e. 24 hrs x 7 days round the clock till completion of CMC period i.e. 5 years from date of functioning of complete system. The comprehensive maintenance contract includes repair and replacement of all parts required to make system functional round the clock. The successful bidder shall attend call of the department for any type of repair/defect/malfunctioning during CMC period immediately without any charges, whatsoever in this regard.
- (ii) The successful bidder shall replace with stand-by spare parts of equal technical specification till rectification of major/minor repair to make the system functional round the clock i.e. 24 hours x 7 days. In case of failure (minor repair) successful bidder shall be given 24 hrs to rectify the same from date and time of complaint, if not rectified within 24 hours, a penalty as per penalty clauses (beyond 24 hrs from the time of complaint up to 3 days) shall be imposed. In case of replacement of parts requires (major repair), time limit is seven days beyond 24 hours from the time of complaint, otherwise the penalty as per penalty clauses shall be imposed.
- (iii) The successful bidder shall be liable for any loss/damage claimed by third party in case non-functioning/unavailability of footage of CCTV for the region where CCTV's are installed.

### **14. PENALTY CLAUSES:**

- 14.1 Penalty shall be imposed as follows:-

S.No.	Description	Penalty /Other Actions
1.	Delay in submission of performance security up to 30 days.	Rs. 2,000/- per day
2.	In case of delay in Supply, Install, Testing, Commissioning of complete system.	Rs. 500/- per day
3.	In case of delay in repair of cameras and its allied components for minor repair	Rs. 500/- per day per incident
4.	In case of delay in repair of cameras and its allied components for major repair (i.e. if requires replacement of spare part)	Rs.1000/- per day per incident

- 14.2 If successful bidder will not rectify the defect within 4 days or 7 days (major repair or minor repair respectively) even after imposing of penalty or if repetition of same defects shall occur more than three times in a month without proper justification then CTU will be at liberty to cancel the contract and forfeit performance security.

### **15. VALIDITY OF TENDER.**

The offer of tender will be valid for a period of 180 days from the date of opening of technical bid. Withdrawal of offer of finalized firm during this period shall result into forfeiture of earnest money.



## 16. **SECRECY**

- 16.1 Any information obtained in the course of the execution of the contract by the Bidder/Bidder, his servants or agents or any person so employed, as to any matter whatsoever, which would or might be directly or indirectly, of use to any enemy of India, must be treated secret and shall not at any time be communicated to any person.
- 16.2 Any breach of the aforesaid conditions shall entitle the Department to cancel the contract and to hiring or authorize the hiring of the buses at the risk and cost of the Bidder/Bidder, as applicable.

## 17. **INSPECTION OF INSTALLATION OF COMPLETE SYSTEM**

- 17.1 Department or representative(s) authorized by the Department shall carry out inspection of CCTV Cameras after installation and commissioning.
- 17.2 For any Deficiency noted by the Department, the successful bidder shall initiate immediate remedial actions for the same as advised by the Department.

## 18. **REMOVAL OF REJECTED CCTV CAMERAS**

On rejection of CCTV Cameras, during the inspection or assessment of performance during testing and commissioning the camera (s) shall be removed and replaced by the Bidder/Bidder at his own cost within a week from the date of intimation of such rejection.

## 19. **SETTLEMENT OF DISPUTE AND ARBITRATION-**

### 19.1 **Amicable resolution**

- (a) Save where expressly stated otherwise in this Contract, any dispute, difference or controversy of whatever nature howsoever arising under, out of or in relation to this Contract between the Parties and so notified in writing by either Party to the other (the "Dispute") in the first instance shall be attempted to be resolved amicably by the Parties and failing such the same shall be resolved in accordance with the procedure set forth in **sub-clause (b)** below.
- (b) Either Party may require the Dispute to be referred to Transport Secretary, Union Territory, Chandigarh for amicable settlement. Upon such reference, both the Parties and the Transport Secretary or his nominee (who can be an employee of Chandigarh UT dealing with the Contract or otherwise) shall meet at the earliest mutual convenient and in any event within 15 (fifteen) days of such reference to discuss and attempt to amicably resolve the Dispute. If the Dispute is not amicably resolved within 15 (fifteen) days of such meeting, either Party may refer the Dispute to arbitration in accordance with the provisions given below.

### 19.2 **Arbitration-**

- (a) Any Dispute which is not resolved amicably, as provided, shall be finally settled by referenced to arbitration and such arbitration shall be held in accordance with the provisions of the Arbitration and Conciliation Act, 1996.
- (b) **Place of Arbitration.**  
The place of arbitration shall be Chandigarh only.
- (c) **Language**  
The request for arbitration, the answer to the request, the terms of reference, any written submissions, any orders and rulings shall be in English and, if oral hearings take place, English shall be the language to be used in the hearings.
- (d) **Enforcement of Award**  
Any decision or award resulting from arbitration shall be final and binding upon the Parties. The parties hereto hereby waive, to the extent permitted by Law, any rights to appeal or to review of such award by any Court or Tribunal. The Parties here to agree that the arbitral award may be enforced against the Parties to the arbitration proceedings or their assets wherever they may be found and that a judgment upon the arbitral award may be entered in any Court having jurisdiction thereof.

**(e) Fees and Expenses**

The fees and expenses of the arbitrators and all other expenses of the arbitration shall be initially borne and paid by respective parties equally subject to determination by the arbitrators. The arbitrators may provide in the arbitral award for the reimbursement to the prevailing party of its costs and expenses in bringing or defending the arbitration claim, including legal fees and expenses incurred by the said party.

**(f) Performance during Arbitration**

Pending the submission of and / or decision on a dispute difference or claim or until the arbitral award is published the parties shall continue to perform all of their obligations under this Contract without prejudice to a final adjustment in accordance with such award.

**20. GENERAL TERMS AND CONDITIONS.**

- 20.1 The prices/rates to be quoted by the intending bidder/bidder shall include the supply, laying of cables including digging/boring and installations, at the site, of all equipment, ancillary material and other items whatsoever required for carrying out the job to fulfill the intent and purpose as laid down in the specifications. The bidder price shall be deemed to include all nuts, bolts, shims, clamps, supports, components etc., as required for proper fixing and/or grouting of equipment, ancillary items, etc. as per requirement for the installation, Testing & Commissioning of complete system.
- 20.2 The rates quoted should be F.O.R. destination (excluding taxes/GST). i.e. CTU Depots/ISBTs, Chandigarh or the place specified by the office. The GST/taxes as applicable from time to time.
- 20.3 Materials/items other than mentioned in RFP and with different specifications will not be accepted.
- 20.4 Standard quality material will only be accepted as per specification mentioned in the tender documents.
- 20.5 Materials received with other than desired specifications/Sub standard materials shall be returned at bidder's risk and cost or it may be kept in CTU Depot workshop at bidder's risk and bidder will have to make replacement of these items within fifteen days from the date of inspection by committee failing which, the recovery equivalent to the amount of sub standard materials/other specifications materials will be made from the payment of bills.
- 20.6 All the documents/GRs must be sent direct to this office. The payment will be made through bank draft/RTGS as per the schedule/terms of payment mentioned in the tender.
- 20.7 The requirements of items/Cameras are based on anticipated requirement and therefore quantity can be increased or decreased as per the actual requirement basis. The payment will be given on actual requirement basis.
- 20.8 Payment will be made as mentioned under clause Terms of Payment subject to recoveries if any and duly checked and verified by the CTU Inspection Committee.
- 20.9 Earnest money/performance security and/or any other sum of the bidder(s) lying with office of the Divisional Manager, CTU & Director Transport, U.T., Chandigarh, Plot No. 701, Industrial Area, Phase I,, Chandigarh in connection with any other tender/case shall not be considered/ adjusted against this tender.
- 20.10 Any conditional, telegraphic tenders, fax tenders, tender without earnest money deposit, tender not on the prescribed form or any deviation from the terms and conditions of the tender notice shall not be entertained and rejected out rightly.
- 20.11 Any conditional terms and conditions mentioned by the firm in their covering letter or in the tender documents will not be considered at any circumstances.
- 20.12 The quantities of items under may vary according to the network designed by the bidder & site requirements. This will be decided during detail engineering and shall be subject to approval of the Director Transport, CTU, Chandigarh. The payment shall be made on actual basis for these items.

- 20.16 The successful bidder (firms/Companies) is liable to install complete system as defined in BoQ along with its allied equipments (Complete job) within one month from the date of issue of rate award letter. In case, the successful bidder backs out or failed to do the job, the Earnest Money Deposit/security shall be forfeited and the bidder shall be black listed for any future contract as per Chandigarh Administration, Finance Department Notification No. 1927- F&PO(3)-2009/1170, dated 27.2.2009 on the following types of situations:-
- i) Dishonest/fraudulent/sharp practices are indulged in by the party.
  - ii) Advancing a claim on the basis of forged documents.
  - iii) Sale or supply of spurious items and compromising public safety.
  - iv) Material concealment/suppression of facts or gross misrepresentation of facts.
  - iv) Any other case or situation involving national security.
  - v) On breach of any of the terms and conditions of the RFP/Tender.
