TECHNICAL BID

TERMS & CONDITIONS:-

- 1. The firm should fulfil any one of below mentioned eligibility criteria:-
 - (i) The firm should be holding valid TS-16949:2002 certification for manufacturing Tyres, Tubes and Flaps. OR
 - (ii) The firm should be holding valid BIS certification IS:15636:2012 as notified in CMVR for tyres and tubes for tyres must conform to IS:13098 only and should have standard mark of BIS.

OR

- (iii) The firm should be O.E. suppliers to any bus manufacturer for tyres sets.
- 2 The offer of tender will be valid for a period of 180 days from the date of opening/down loading of technical documents. Withdrawal of offer of finalized firm during this period will result into forfeiture of earnest money.
- Tender must be accompanied with a Earnest Money as mentioned against each item in the tender notice in the shape of Demand Draft in favour of "Director Transport, U.T., Chandigarh" drawn on any Scheduled bank in Chandigarh. In case of successful tender, the successful bidder will have to deposit performance security @ 5% of the total supply ordered amount in the form of Fixed Deposited Receipt (FDR) from a commercial bank or a Bank Guarantee in favour of "Director Transport U.T., Chandigarh" which should be valid for a period of fifteen months from the date of supply order and will have to be deposited within 21 days from the date of issue of the letter of acceptance of tender/ 1st supply order.
- 4. The tenderer will offer their landed rates for one complete set of Tyre, Tube, & Flap including all taxes, Govt. levies etc.
- 5. The cash discount may also be intimated against the advance payment, if any.
- 6. Successful tenderers will be required to supply the tyres at FOR Destination. In case of delay in the supply, the tyres, tubes, Flaps will be purchased at the risk and cost of the tenderer at extra expenses, if any, will be recovered from the tenderer in default. If supply is rejected due to manufacturing defects, the tenderer shall lift the material at their own cost within 10 days otherwise Godown charges will be levied @ 10 % of the value of the supply per day of delayed lifting of material.

- 7. The supply order will be placed as per monthly requirement only and supply will be made within two weeks otherwise penalty @ 1% per day of the value of the material will be levied for delay period. The Competent Authority may also forfeit the security in case of delay of the supply of more than one month without assigning any reason.
- 8. Payment will be made against physical satisfactory delivery of material.
- 9. The landed rates for individual item i.e. Tyres, Tubes and Flaps for extra supply of these items may also be indicated separately.
- 10. Rates should be mentioned both in figures as well as in words. In case of any discrepancies in rates, the rates mentioned in words will be considered.
- Incomplete / conditional tender or tender received without earnest money shall not be considered and liable to be rejected out rightly.

12. The validity of quoted/finalized rates will be one year from the date of placement of supply order.

- 13. The successful tenderer will have to furnish an affidavit that the quoted rates in the tender are not more/higher than the rates already quoted anywhere in any State Transport Undertaking/ any Govt. Organization/PSUs during last six months. If it is found that the quoted rates are higher than the rates quoted in any other Govt./PSU supplies, the total difference of rates/prices will be recovered from the firms.
- 14. The firm will liable to be blacklisted as per Chandigarh Administration, Finance Department Notification No. 1927-F&PO (3)-2009,dated 27.02.2009 the following types of situations:-
- i) Dishonest/fraudulent/sharp practices are indulged in by the party.
- ii) Advancing a claim on the basis of forged documents.
- iii) Sale or supply of spurious items and compromising public safety.
- iv) Material concealment/suppression of facts or gross misrepresentation of facts.
- v) Any other case or situation involving national security.

- 15. In case bidder withdraws its offer within the validity period, submit forged/fake documents or do any unethical/un-business like activity, do not accept the supply order, do not supply 1st.delivery schedule/do not submit Bank Guarantee, EMD of the firm will be forfeited and other departmental penal action, as deemed fit, will be taken.
- 16. Any conditional terms and conditions mentioned by the firm in their covering letter or in the tender documents will not be considered.
- 17. The firm will have to supply the evidence of Excise Duty paid along with each invoice, if any .
- 18. The quantity for the supply can be decreased /increased by 25% during the contract period on the same rate and terms and conditions, as per actual requirement of the department.
- 19. Firm should have capability to supply tendered quantities, during contract period.
- 20. The firm has to furnish an affidavit along with the tender documents. "That the firm has not been black listed or debarred in the past from doing any business in this field in any state transport/undertaking/any Govt. organization/ PSUs or any Govt. agencies in India".

21. **FINANCIAL ANNUALTURN OVER**

The bidder should have minimum turn over of Rs. 2.00 Crore (Rupees Two Crore only) in the last balance sheet for the last two preceding years ending 31.3.2015 duly attested by C.A. The bidder has to submit its documentary proof for the same.

- 22. The tenders submitted directly by the manufacturers meeting eligibility criteria to quote the rates for tyres, tubes, flaps will only be considered. The supply will be accepted directly from the manufacturers only and not through dealer / distributor/Agent.
- 23. The successful tenderer will not have any objection to the supplied materials (Tyre, Tube, &, flap) being tested in any NABL accredited Govt. approval laboratories or CIRT Pune for its quality check as per laid down specifications.

- 24. **Arbitrator**: All disputes and differences arising out of or concerning what so ever shall be referred to the sole Arbitrator or an Officer appointed by Secretary Transport, Chandigarh Administration, Chandigarh acting as such at the time of the reference and hence will be no objection to such appointment, that the Arbitrator so appointed is a Govt. Servant that he has to deal with such matters in the course of duties as Govt. servant and might have expressed views on all or any of the matters in disputes or differences. The arbitrator shall award/finalize the dispute within one year. The award of such Arbitrator shall be final and binding on, the parties involved. The Arbitrator has the power to extend the time for making the award on request from either of the parties.
- 25. **Jurisdiction:** Any dispute or difference or claim etc, shall be subject to the exclusive jurisdiction of the courts situated at Chandigarh only. No other court shall have the jurisdiction to entertain or try any matter concerning this supply tender.
- 26. The tenderer will be responsible to see that the tender is uploaded on or before the due date and time on website.
- 27. Each page containing terms & conditions of the tender should be signed by the tenderers with stamp of the firm.
- 28. The offer should be legibly typed.
- 29. The due date and time of receipt of tenders is 14.00 hours on dated 12.04.2016. Any tender which is received after on the due date and time shall not be considered.
- 30. The Technical Bid will be opened on 12.04.2016 at 15.00 hours & date of opening of Financial Bid shall be intimated later on.
