#### 1. Scope of work:-

The scope of work to be undertaken by the successful bidder as mentioned in the RFP/tender document and in compliance with the technical specification and Bill of Quantity. The scope of work includes supplying, installation, testing, commissioning of CCTV cameras, Network Video Recorders, switches, POE cable, power cable, poles for mounting CCTV cameras, Racks, Mounting brackets, PVC conduit/G.I. piping for laying cables etc. or any work associated thereto. The works includes design and execute an IP network based surveillance system and provide turn-key solution for the entire project. IP Dome and Bullet Cameras are required to be installed at various locations as per the requirement of Chandigarh Transport Undertaking (CTU) at ISBT-17, ISBT-43 or Depot's of CTU and to make system functional complete in all respect. Digging/Boring, filling of earth, Chipping of walls and ensuring to make the site to its original condition shall be the responsibility of the successful bidder including supply and installation of poles, housing & any additional fixtures. The work should be state of art and to be done in neat and clean manner. #### 2 **QUALIFICATION CRITERIA**

#### 2.1 TECHNICAL QUALIFICATION CRITERIA:-

- i) The prospective bidder must be either OEM itself OR Authorized Distributor/Dealer of approved makes of CCTV & NVR as mentioned in annexure-'A1'. The documentary proof duly notarized must be attached along with technical bid.
- ii) Experience of similar nature of 2 (two) project in last three years as on 31.03.2018 consisting at least 50 IP CCTV Cameras for each project in Government sector or Private sector (Fixed/Dome/PTZ etc.). Satisfactory performance/completion certificate and purchase orders (duly notarized or self attested) must be attached along with the technical bid
- iii) The prospective bidder must have Registered service tax number/GST should be attached with the technical bid.

#### 2.2 **FINANCIAL QUALIFICATION CRITERIA**:

The bidder should have average annual turnover of Rs. 50.00 Lakh (each year) (Rupees Fifty Lakh only) during the last three preceding years ending on 31.03.2016, 31.3.2017 and 31.3.2018 duly attested/audited by Chartered Accountant (CA). The bidder has to submit its documentary proof for the same.

#### 9 TIME PERIOD FOR THE COMPLETION OF WORK:

The work for the supply, installation, testing and commissioning (complete job) should be completed within one month from the date of the Letter of Award (LOA)/work order.

#### 10 DEPARTMENT RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL BIDS

The Department reserves the right to accept or reject any Bid, and to annul the Bid Process and reject all Bids without assigning any reason.

#### 11 PERFORMANCE SECURITY-

The comprehensive maintenance contract includes repair and replacement of all parts required to make system functional round the clock. The successful bidder shall attend call of the department for any type of repair/defect/malfunctioning during CMC period immediately without any charges, whatsoever in this regard.
- (ii) The successful bidder shall replace with stand-by spare parts of equal technical specification till rectification of major/minor repair to make the system functional round the clock i.e. 24 hours x 7 days. In case of failure (minor repair) successful bidder shall be given 24 hrs to rectify the same from date and time of complaint, if not rectified within 24 hours, a penalty as per penalty clauses (beyond 24 hrs from the time of complaint up to 3 days) shall be imposed. In case of replacement of parts requires (major repair), time limit is seven days beyond 24 hours from the time of complaint, otherwise the penalty as per penalty clauses shall be imposed.

#### 15. VALIDITY OF TENDER.

The offer of tender will be valid for a period of 180 days from the date of opening of technical bid. Withdrawal of offer of finalized firm during this period shall result into forfeiture of earnest money.

#### 16. SECRECY

- 16.1 Any information obtained in the course of the execution of the contract by the Bidder/Bidder, his servants or agents or any person so employed, as to any matter whatsoever, which would or might be directly or indirectly, of use to any enemy of India, must be treated secret and shall not at any time be communicated to any person.
- 16.2 Any breach of the aforesaid conditions shall entitle the Department to cancel the contract and to hiring or authorize the hiring of the buses at the risk and cost of the Bidder/Bidder, as applicable.

#### 17. INSPECTION OF INSTALLATION OF COMPLETE SYSTEM

- 17.1 Department or representative(s) authorized by the Department shall carry out inspection of CCTV Cameras after installation and commissioning.
- 17.2 For any Deficiency noted by the Department, the successful bidder shall initiate immediate remedial actions for the same as advised by the Department.

#### 18. REMOVAL OF REJECTED CCTV CAMERAS

On rejection of CCTV Cameras, during the inspection or assessment of performance during testing and commissioning the camera (s) shall be removed and replaced by the Bidder/Bidder at his own cost within a week from the date of intimation of such rejection.

#### 19. SETTLEMENT OF DISPUTE AND ARBITRATION-

#### 19.1 Amicable resolution

- (a) Save where expressly stated otherwise in this Contract, any dispute, difference or controversy of whatever nature howsoever arising under, out of or in relation to this Contract between the Parties and so notified in writing by either Party to the other (the "Dispute") in the first instance shall be attempted to be resolved amicably by the Parties and failing such the same shall be resolved in accordance with the procedure set forth in sub-clause (b) below.
- (b) Either Party may require the Dispute to be referred to Transport Secretary, Union Territory, Chandigarh for amicable settlement. Upon such reference, both the Parties and the Transport Secretary or his nominee (who can be an employee of Chandigarh UT dealing with the Contract or otherwise) shall meet at the earliest mutual convenient and in any event within 15 (fifteen) days of such reference to discuss and attempt to amicably resolve the Dispute. If the Dispute is not amicably resolved within 15 (fifteen) days of such meeting, either Party may refer the Dispute to arbitration in accordance with the provisions given below.

#### (b) Place of Arbitration.

The place of arbitration shall be Chandigarh only.

#### (c) Language

The request for arbitration, the answer to the request, the terms of reference, any written submissions, any orders and rulings shall be in English and, if oral hearings take place, English shall be the language to be used in the hearings.

#### (d) Enforcement of Award

Any decision or award resulting from arbitration shall be final and binding upon the Parties. The parties hereto hereby waive, to the extent permitted by Law, any rights to appeal or to review of such award by any Court or Tribunal. The Parties here to agree that the arbitral award may be enforced against the Parties to the arbitration proceedings or their assets wherever they may be found and that a judgment upon the arbitral award may be entered in any Court having jurisdiction thereof.

#### (e) Fees and Expenses

The fees and expenses of the arbitrators and all other expenses of the arbitration shall be initially borne and paid by respective parties equally subject to determination by the arbitrators. The arbitrators may provide in the arbitral award for the reimbursement to the prevailing party of its costs and expenses in bringing or defending the arbitration claim, including legal fees and expenses incurred by the said party.

#### (f) Performance during Arbitration

Pending the submission of and / or decision on a dispute difference or claim or until the arbitral award is published the parties shall continue to perform all of their obligations under this Contract without prejudice to a final adjustment in accordance with such award.

#### 20. GENERAL TERMS AND CONDITIONS.

- 20.1 The prices/rates to be quoted by the intending bidder/bidder shall include the supply, laying of cables including digging/boring and installations, at the site, of all equipment, ancillary material and other items whatsoever required for carrying out the job to fulfill the intent and purpose as laid down in the specifications. The bidder price shall be deemed to include all nuts, bolts, shims, clamps, supports, components etc., as required for proper fixing and/or grouting of equipment, ancillary items, etc. as per requirement for the installation, Testing & Commissioning of complete system.
- 20.2 The rates quoted should be F.O.R. destination (excluding taxes/GST). i.e. CTU Depots/ISBTs, Chandigarh or the place specified by the office. The GST/taxes as applicable from time to time.
- 20.3 Materials/items other then mentioned in RFP and with different specifications will not be accepted.
- 20.4 Standard quality material will only be accepted as per specification mentioned in the tender documents.
- 20.5 Materials received with other than desired specifications/Sub standard materials shall be returned at bidder's risk and cost or it may be kept in CTU Depot workshop at bidder's risk and bidder will have to make replacement of these items within fifteen days from the date of inspection by committee failing which, the recovery equivalent to the amount of sub standard materials/other specifications materials will be made from the payment of bills.
