- 2. Every quotation shall be valid for six months from the date of issue of rate acceptance letter.
- Standard material of same Make as mentioned in the column of "Make of the Item" will only be accepted as approved by the inspection committee constituted for the purpose.
- 4. The validity period/expiry date of the medicines should not less than one year from the date of supply of the medicine/kit to the CTU.
