#### 1. About the Project and Scope of Project :-

The Chandigarh Transport Undertaking (CTU), Chandigarh having the fleet of 567 (approx) buses (make TATA/LEYLAND/SML/ CORONA) which are plying on urban and sub urban routes of the Tricity Chandigarh, Panchkula and Mohali and interstate routes/long routes. The CTU is intends to procure automotive batteries from time to time as per detail mentioned in Annexure-'A' for the use in the Buses. The approximate contract value of this tender is Rupees 35-40 Lakhs. The detail of the required batteries for one year is as under:-

#### 2. Eligibility Criteria:

## 2.1 <u>TECHNICAL QUALIFICATION CRITERIA</u> (supporting documents to be <u>attached</u>:-

i) The firm should be reputed manufacturing firm for the batteries and on rate contract approved by ASRTU, Delhi as per latest ASRTU specifications. The bidder must attach the copy of firm's registration as manufacturer and copy of valid rate contract of ASRTU, Delhi.

#### OR

ii) The firm should be OE supplier to any commercial vehicle manufacturer for the three preceding year ending on 31.3.2018 and holding valid TS-16949:2002 certification for manufacturing Batteries and AS:311 :69:JULY :2005, AS:62:68: DEC :2004, AS:347:67 :JULY :2004 or latest. The bidder must attach the copy of firm's registration and copy of valid certificates and proof of OE supplier as referred above.

#### **OR**

iii) The firm should be authorized dealer/distributor of any supplier as stated at i) & ii) above. The copy of the firm registration/ authorization certificate and valid TS certificate/manufacturing certificate as referred in clause i) and ii) above must be submitted with the technical bid online.

- **2.2 FINANCIAL QUALIFICATION:** (supporting documents to be uploaded with technical bid).
  - The bidder should have minimum annual turnover of **Rs.2.00 crore** (**Rupees. Two Crore only**) in the last balance sheet for each year in last three preceding years ending on 31.3.2016, 31.3.2017 and 31.3.2018 duly attested/audited by Chartered Accountant (CA).
  - ii) ITR for last three financial years ending on 31.03.2016, 31.03.2017 & 31.03.2018 along with copy of PAN card and GST no. to be attached.

#### 4. BID SECURITY / EARNEST MONEY DEPOSIT (EMD) -

- 4.1 The Bidder shall furnish separate Bid security (hereinafter also referred to as Earnest Money Deposit" (EMD) of Rs.1,00,000/- (Rs.One Lakh, only) as a part of this Bid. The bid security shall be sealed in a separate sealed envelope super scribed "Earnest Money Deposit" for Bid due on 29-10-2018 upto 14.00 hours for the supply of automotive batteries for CTU buses to be deposited. The Earnest Money Deposit (EMD) with validity period of at least 180 days beyond the financial bids validity period should be in the form of "Bank Guarantee/Demand Draft/FDR" payable in favour of Divisional Manager, CTU, &, Director Transport, Union Territory, Chandigarh payable /en-cashable at Chandigarh of any nationalized / Scheduled Commercial Bank, operating in India.
- 4.2 Any Bid not accompanied with valid and required as per RFP/Tender Bid Security/EMD in the acceptable form will be rejected by the Purchaser considering it as non-responsive.

#### 5. Submission of Bid

Technical Bid and Financial Bid are to be uploaded separately online at <a href="http://etenders.chd.nic.in/">http://etenders.chd.nic.in/</a> using digital signature certificate and EMD in physical form should reach in CTU office before due date and time of tender as mentioned under clause 3 above.

#### 6. BIDDING CRITERIA:-

Bidders are required to quote their rates including landed rates (FOR Destination for a period of one year excluding taxes. The taxes shall be as applicable from time to time. The contract will be awarded to the bidder whose rates are lowest (excluding all taxes).

#### 7. **EVALUATION OF BID:**-

The Tender shall be awarded to the bidder, whose rates are Lowest rate in the Price Bid (excluding all taxes), provided he fulfills all other terms and conditions of the tender documents.

#### 8. PAYMENT TERMS:-

- 8.1 The Payment will be made against physical satisfactory delivery of material in good conditions in the CTU store and duly checked and verified by the Inspection Committee of the Department.
- 8.2 All the documents/GRs must be sent direct to this office. The payment will be made through bank draft/RTGS within 45-60 days from the date of receipt of material in the CTU main Store.

#### 9. DISCHARGE OF BID SECURITY OF UNSUCCESSFUL BIDDERS(S)

The Bid Security of unsuccessful Bidders will be discharged / returned as promptly as possible after the expiry of Bid validity period and / or within 15 days from the date of signing the agreement/Issue of Letter of Award with the successful bidder.

#### 10. DISCHARGE OF BID SECURITY OF SUCCESSFUL BIDDER(S)

- 10.1 The bid security of the Successful Bidder(s) shall be discharged only after the Successful Bidder(s) furnishes the Contract Performance Security as required.
- 10.2 If the successful Bidder(s) fails to furnish the Contract Performance Security within the requisite period then the Bid Security shall be liable to be forfeited by the Purchaser.

#### 11 **BID VALIDITY**.

- 11.1 The bid shall remain valid and open for acceptance for a period of 180 days from the date of opening/downloading the technical bids of tender.
- 11.2 In exceptional circumstances prior to expiry of the original bid validity period, the Purchaser may request the Bidder for extension in the period of validity. A Bidder may refuse the request without becoming liable for forfeiture of EMD. However this bid may be rejected by the Purchaser on such refusal. Moreover, the bidder agreeing to the request will not be permitted to modify his Bid.

#### 12. TERMS OF CONTRACT.

Tender shall be valid for one year from the date of issue of Letter of Acceptance (LOA) which can be extendable further for one year on mutual consent of the parties. But the bidder cannot claim for the grant of extension in contract as a matter of right.

#### 13. PERFORMANCE SECURITY:

The successful bidder shall submit the performance security @ 05% of the total value of the contract within 21 days from the date of issuance of the Letter of Acceptance /Purchase order in the form of Bank Guarantee/Fixed Deposit Receipt (FDR) from any scheduled bank payable at Chandigarh in an acceptable form which should be valid for a period of 15 months from the date of Letter of Acceptance./1<sup>st</sup> supply order.

#### 14. **PENALTIES.**

- 14.1 The successful tenderers will be required to supply the items/materials at FOR Destination within 15 (fifteen) days from the date of issue of Purchase Order issued from time to time. In case of delay in the supply, the material will be purchased from the open market at the risk and cost of the tenderer and the expenses will be recovered from the tenderer in default.
- 14.2 If supply/material is rejected due to any defects, the tenderer shall lift the material at their own cost within 10 days otherwise Godown charges will be levied @ 10% of the value of the supply per day of delayed lifting of material.

- 14.3 The supply order will be placed as per monthly requirement only and supply will be made within two weeks otherwise penalty @ 1% per day of the value of the material will be levied for delay period. The Competent Authority may also forfeit the security in case of delay of the supply of more than one month without assigning any reason.
- 14.4 In case of failure of sample of the batteries in testing as per ASRTU weight chart or in other specifications, the penalty will be imposed equivalent to the value of the such supply order and the penalty amount will be recovered from the tenderer in default.
- 14.5 Withdrawal of offer of finalized firm during this period will result into forfeiture of earnest money/security.
- 14.6 In case bidder withdraws its offer within the validity period, submit forged/fake documents or do any unethical/un-business like activity, do not accept the supply order, do not supply 1<sup>st</sup>.delivery schedule/do not submit Bank Guarantee, the EMD of the firm/bidder will be forfeited and other departmental penal action, as deemed fit, will also be taken.

#### 15 GENERAL TERMS AND CONDITIONS:-

- 15.1 The rates quoted should be F.O.R. destination, landed rate i.e. CTU Main Store, Workshop Depot No.1, Industrial Area, Phase-1, Chandigarh or the place specified by the office. The tenderer will offer their landed rates of each battery separately excluding all taxes/duties. The taxes/GST will be as applicable from time to time. The lowest bidder shall be decided on the basis of lowest rates quoted for each item separately.
- 15.2 The quantity for the supply can be decreased /increased by 25% during the contract period on the same rate and terms and conditions, as per actual requirement of the department.
- 15.3 The supply will be accepted directly from the successful bidder only.
- 15.4 The successful tenderer will not have any objection to the supplied materials being tested in any NABL accredited Govt. approved laboratories or CIRT Pune or any Govt./Govt approved agency for its quality check as per laid down specifications. In case of failure of sample, penalty will be imposed as per terms & conditions of the tender clause-14 or as decided by Divisional Manager, CTU, & Director Transport, Union Territory, Chandigarh.
- 15.5 The successful bidder is liable to supply the material within 15 (fifteen) days from the date of issue of the Purchase Order issued from time to time.

- 15.6 Materials received with other than desired specifications/ Sub standard materials will be returned at bidder's risk and cost or it may be kept in CTU Depot workshop at bidder's risk and bidder will have to make replacement of these items within fifteen days from the date of inspection by committee failing which, the recovery equivalent to the amount of sub standard materials/other specifications materials will be made from the payment of bills.
- 15.7 The Batteries supplied should be having a minimum guarantee of 24 month. In any premature of any automotive battery, the same will be inform to the firm for joint inspection of the premature failed battery and after the receipt of the complaint, the firm should settled the issue of premature failed reported battery, otherwise a recovery will be made from the payment of the firm/performance security without giving any notice.
- 15.8 The department is reserve rights to purchase the tender material during contract period from other firm/source at the same rate in case of non supply of the material by successful bidder within the stipulated period. For this the firm (successful bidder) is not entitled to claim for this action of the department.
- 15.9 The department reserves the right to modify/revoke the order/agreement at any point of time without assigning any reason.
- 15.10 The Firm/bidder should have capability to supply tendered quantities, during contract period.
- 15.11 Incomplete / conditional tender or tender received without earnest money shall not be considered and liable to be rejected out rightly
- 15.12 The tenders received after the stipulated date and time shall not be entertained/opened.
- 15.13 The tenderers will be responsible to see that the tender is uploaded on or before the due date and time on website
- 15.14 The tenders shall be opened in the presence of intending tenderers or their authorized representatives if they wish to be present at that time.
- 15.15 The tenderers can approach the Nodal Officer, e-tendering, CTU Chandigarh on any working day between 9:00 A.M to 5:00 P.M. in case of any query /clarification regarding e-tendering process (Phone No. 0172-2679003).
- 15.16 Any conditional terms and conditions mentioned by the firm in their covering letter or in the tender documents will not be considered.
- 15.17 The firm/bidder will liable to be blacklisted as per Chandigarh Administration, Finance Department Notification No.1927-F&PO(3)-2009/1170, dated 27.02.2009 on the following types of situations:
  - i) Dishonest/fraudulent/sharp practices are indulged in by the party.
  - ii) Advancing a claim on the basis of forged documents.
  - iii) Sale or supply of spurious items and compromising public safety.
  - iv) Material concealment/suppression of facts or gross misrepresentation of facts.
  - v) Any other case or situation involving national security.
  - vi) On breach of any of the terms and conditions of this tender

#### 16. SETTLEMENT OF DISPUTE AND ARBITRATION-

#### 16.1 Amicable Resolution

- (a) Save where expressly stated otherwise in this Contract, any dispute, difference or controversy of whatever nature howsoever arising under, out of or in relation to this Contract between the Parties and so notified in writing by either Party to the other (the "Dispute") in the first instance shall be attempted to be resolved amicably by the Parties and failing such the same shall be resolved in accordance with the procedure set forth in **sub-clause** (b) below.
- (b) Either Party may require the Dispute to be referred to Transport Secretary, Union Territory, Chandigarh for amicable settlement. Upon such reference, both the Parties and the Transport Secretary or his nominee (who can be an employee of Chandigarh UT dealing with the Contract or otherwise) shall meet at the earliest mutual convenient and in any event within 15 (fifteen) days of such meeting, either Party may refer the Dispute to arbitration in accordance with the provisions given below.

#### 16.2 Arbitration-

(a) Any Dispute which is not resolved amicably, as provided, shall be finally settled by binding arbitration under the Arbitration and Conciliation Act, 1996. The arbitration shall be by a committee of 3 (three) arbitrators chosen from a panel of arbitrators on the list of arbitrators available with or furnished by Union Territory, Chandigarh, 1 (One) arbitrator is to be chosen by each Party and the third, who shall be the Chairman will be the Transport Secretary, Chandigarh Administration, Chandigarh. If either Party fails to choose its arbitrator, the other Party shall take steps in accordance with Arbitration and Conciliation Act, 1996.

#### (b) Place of Arbitration

The place of arbitration shall be Chandigarh only.

#### (c) Language

The request for arbitration, the answer to the request, the terms of reference, any written submissions, any orders and rulings shall be in English and, if oral hearings take place, English shall be the language to be used in the hearings.

#### (d) Procedure

The procedure to be followed in the arbitration by the Arbitral Tribunal shall be in accordance with the Arbitration & Conciliation Act, 1996 and as may be decided by the Arbitral Tribunal.

#### (e) Enforcement of Award

Any decision or award resulting from arbitration shall be final and binding upon the Parties. The parties hereto hereby waive, to the extent permitted by Law, any rights to appeal or to review of such award by any Court or Tribunal. The Parties here to agree that the arbitral award may be enforced against the Parties to the arbitration proceedings or their assets wherever they may be found and that a judgment upon the arbitral award may be entered in any Court having jurisdiction thereof.

#### (f) Fees and Expenses

The fees and expenses of the arbitrators and all other expenses of the arbitration shall be initially borne and paid by respective parties equally subject to determination by the arbitrators. The arbitrators may provide in the arbitral award for the reimbursement to the prevailing party of its costs and expenses in bringing or defending the arbitration claim, including legal fees and expenses incurred by the said party.

#### (g) Performance during Arbitration

Pending the submission of and/ or decision on a dispute difference or claim or until the arbitral award is published the parties shall continue to perform all of their obligations under this Contract without prejudice to a final adjustment in accordance with such award.

#### 17. JURISDICTION

Any dispute or difference or claim etc, shall be subject to the exclusive jurisdiction of the courts situated at Chandigarh only. No other court shall have the jurisdiction to entertain or try any matter concerning this supply/tender.
