PERFORMANCE SECURITY:- Page No. 11 Clause No. 13	The successful bidder will have to deposit performance security equivalent to one third (1/3) of the value of the annual contract in the form of FDR or a irrevocable and unconditional Bank Guarantee from a commercial/scheduled bank, pledged in favour of "Chandigarh City Bus Services Society, Chandigarh" so as to ensure that contractual liability on the part of successful bidder is met out in case of any default on his part during the entire period of contract and will have to be deposited within 21 days from the date of Issue of Letter of Acceptance of Tender/Bid failing which the EMD shall be liable to be forfeited and letter of acceptance of tender/contract will stand cancelled. The validity of performance security shall be 60 days beyond the validity of the contract period. Definitions and Abbreviations Page No. 4	Bidder means a proprietor/partnership firm or a company/consortium incorporated in India engaged in Maintenance of buses.	Bidder means a proprietor/partnership firm or a company/JV/consortium incorporated in India engaged in Maintenance of buses. In case of Joint Venture/Consortium, up to two members shall be allowed with at least one of the partner having more than 51% share who shall be the lead partner.
Clause 3.1 Page 8 Technical Eligibility Criteria	Added with Eligibility clause 3.1 (Technical), Sr. No 1.	In order to meet the condition of experience of maintenance of 100 buses in any State Transport Undertaking for a continuous period of 2 years, the experience of two or more depots cannot be consolidated to achieve the minimum eligibility criteria.

The notice period of four months for termination of contract by either parties be read as three months. Secondly wherever any provision of four months appearing on the tender document be read as three months.
