

TERMS AND CONDITIONS FOR THE INSTALLATION OF AUTOMATIC VEHICLE LOCATION SYSTEM (AVLS) FOR 120 VEHICLES FOR ELECTION DUTY.

1. Tenderers are required to quote their rates for 120 nos. vehicles (like buses, trucks, canters, jeeps and cars) as is and where as basis for **03 days** landed rate excluding taxes for Design, Development, Implementation, Operation and Maintenance of Automatic Vehicle Location System (AVLS i.e. GPS Devices complete job). The taxes shall be as applicable from time to time. The nos. of Vehicle is based on approximate requirement which can be increased or decreased as per actual requirement of the Department. It is clarified that actual payment shall be paid/adjusted as per the actual number of vehicles on pro-rata basis.

2. **About the Project**

CTU desires to implement Automatic Vehicle Location System (AVLS) for the vehicles to be deputed for election duty **for the General Election to the LOK Saba-2019 of Chandigarh Parliamentary Constituency.**

- Putting up GPS device on board.
- Transfer of data in real time to back-end server through GPRS.
- Establishing Data Centre to house Application/data.
- Developing MIS for intelligent use of information as per requirement.
- Developing mobile application and web based portal.
- Sharing information with other platforms- Online as well as Offline.
- Integration with existing set up and separate dashboard for the surveillance of the vehicles put on election duty.

3. **Scope of Project:-**

The 120 Vehicles s are to be deputed for the election duty of the Lok Sabha election-2019 and CTU will look after the locations /routes of these cars during the election duty so CTU is intends to hire the services of Technical Partner for implementing AVLS for ----- vehicles for election duty in General Election-2019.

The Technical partner shall be responsible for the following:-

- On-board GPS Device
- GPRS Communication network.
- Software Application (alongwith source code) and Integration with hardware Infrastructure.
- Developing MIS as per requirement of CTU
- Developing Mobile App/Web portal.

CTU shall provide all hardware support (including Display Panels), back end Computer/Printer or other hardware infrastructure.

4. **No. of Vehicles**

At present, the system is to be installed in 120 nos Vehicle (like buses, trucks, canters, jeeps and cars etc.) which are to be put on for the election duty Lok Sabha election-2019, the number of Vehicle can be increased or decreased depending upon the induction of vehicles for election duty as per actual requirement for the election purpose and the payment will be made accordingly.

5. Terms of Project:-

The term of the project shall be 03 days, extendable by 4-5 days as per the actual requirement of the election duty, Lok Sabha election-2019. The term shall start well before one day from the start of poll and shall close immediately after completion of the election process.

6. Bidding Criteria

This shall be on basis of per Device cost to CTU in INR as per price bid performa attached. The letter of award will be given to the bidder who will quote lowest rates per device excluding all taxes.

7. Technical Experience:-

The bidder must have the experience of similar nature project (AVLS) of more than 50 Vehicles in last proceeding year 2018-19. The proof of the same must attach with the quotation.

8. Payment Terms:-

- i) No Upfront charges will be paid to the Vendor.
- ii) Payment will be paid to the vendor after completion of the election duty and on submission of the bill as well as on the basis of actual devices used in the Vehicles for election duty.

9. Penalty:-

The successful bidder is required to attend any type of repair/defect immediately after getting complaint call from the department without any charges. The system should work continuously during the whole election process and in case, the AVLS system does not work continuously during whole election process due to any technical failure on the part of the vendor, CTU will have the right to initiate the proceeding of blacklisting the vendor or imposing the penalty upon the vendor as may be decided by the Competent Authority.

Note:- Any conditional terms and conditions mentioned by the firm in their covering letter or in the quotation/tender documents will not be considered.
