

TENDER NOTICE

Sealed tenders are invited in two parts i.e. Technical Bid and Commercial Bid from any Bus AC manufacturers or their authorized distributor/ dealers for the purchase of spare parts/materials of required specification (as per list available at website/office as Annexure-“I”) for AC/HVAC buses of CTU Chandigarh.

For any queries, prospective bidders who wish to participate, can visit the office of CTU during any working date/hours and may contact General Manager-I, CTU-I, Assistant Controller (F & A) or Purchase Section for any clarifications w.r.t. tender terms and conditions.

- Bidder is required to deposit required Earnest Money Deposit (EMD) as per tender conditions in this office along with Technical Bid in sealed envelope before due date and time.
- Separate sealed Envelope containing Commercial/Price Bid only must be submitted in CTU office before due date and time.
- Tenderers are required to quote their landed rates i.e inclusive of all taxes/duties/levies for a period of 1 (one) year.
- Tenderer is required to submit a cross demand draft for Rs. 20,000/- (Rupees Twenty Thousand Only) as Earnest Money Deposit (EMD) through bank draft drawn on any scheduled bank at Chandigarh in favour of Divisional Manager, CTU & Director Transport, UT, Chandigarh. Tender received without requisite Earnest Money Deposit (EMD) shall not be considered and rejected out-rightly.
- The tenders in sealed Envelope super scribed “**Tender for the purchase of Spare Parts for AC buses of CTU, Chandigarh**” should be sent only by registered post or submitted by hand in the office Divisional Manager CTU & Director Transport, UT, Chandigarh so as to reach on or before **03.06.2015 at 2.00 PM**. The technical bid containing EMD and signed terms & conditions shall be opened on the same day at 3.00 PM in the presence of the tenderers who may wish to attend in the office room of the Divisional Manager, CTU & Director Transport, UT, Chandigarh. The offer/price of only those tenderers will be opened who are technically qualified in the evaluation of their technical bids. For opening the commercial/price bid, the successful technically qualified bidders will be informed about the time and date of bid opening separately.
- The tender documents received after the stipulated date and time shall not be entertained /opened and will not be considered.
- The offer/price bid documents and detailed terms & conditions of the tender can be obtained from the office of the undersigned on any working day between 9.00 AM to 5.00 PM or can be downloaded from the website <http://chdctu.gov.in>
- The undersigned reserves every right to (a) cancel/withdraw/amend the advertisement or extend the due date at his sole discretion or (b) accept or reject any tender without assigning any reasons.

TERMS AND CONDITIONS FOR THE SUPPLY OF SPARE PARTS/OTHER MATERIALS FOR AC OF BUSES

1. The rates quoted should be F.O.R. destination including all taxes, levies etc. i.e. CTU Depot No.1 Workshop, Industrial Area, Phase I, Chandigarh or the place specified by the office.
2. Tender shall be valid for one year from the date of issue of Letter of Acceptance (LOA).
3. Only those Bus AC manufacturers or Authorized dealers/distributors are eligible to participate who are capable to supply materials/parts as per Annexure-I with specified brand /make of the spares.
4. Materials/spares other than original fitted brand or with different specifications will not be accepted.
5. In case of dealer/distributor bid in the tender, they must attach valid authorization certificate issued by Bus AC manufactures. Tenders received without authorization certificate will not be considered and will be rejected.
6. Standard quality material of specifications as per list will only be accepted as approved by the Inspection Committee constituted for the purpose.
7. Performance Security- An Performance security of Rs. 25,000/- is required to be deposited by successful bidder within 30 days from the date of Letter of Acceptance /Purchase order in the form of Bank Guarantee which is valid for a period of 15 months from the date of Letter of Acceptance.
8. Materials received with other than desired specifications/ Sub standard materials will be returned at bidder's risk and cost or it may be kept in CTU Depot workshop at bidder's risk and bidder will have to make replacement of these items within fifteen days from the date of inspection by committee failing which, the recovery equivalent to the amount of sub standard materials/other specifications materials will be made from the payment of bills.
9. Incomplete/conditional bid will not be entertained.

10. All the documents/GRs must be sent direct to this office. The payment will be made through bank draft/RTGS.

11. The requirements of spares are based on anticipated consumption and therefore quantity can be increased or decreased as per the actual monthly consumption basis. The supply order will be given from time to time on quarterly /half yearly consumption basis.

12. The offer of tender will be valid for a period of 180 days from the date of opening of tender. Withdrawal of offer of finalized firm during this period will result into forfeiture of EMD/ Security, if any.

12. Payment will be made against physical delivery of material in good conditions in the store and duly checked and verified by the Inspection Committee.

13. **Arbitrator** : All disputes and differences arising out of or concerning what so ever shall be referred to the Sole Arbitrator or an officer appointed by Secretary Transport, Chandigarh Administration, Chandigarh acting as such at the time of the reference. Here will be no objection to such appointment, that the Arbitrator so appointed is a Govt. servant that he has to deal with such matters in the course of duties as Govt. servant and might have expressed views on all or any of the matters in disputes or differences.

The award of such Arbitrator shall be final and binding on the parties involved. The Arbitrator has the power to extend the time for making the award on request from either of the parties.

14. **Jurisdiction:** Any dispute or difference or claim etc, shall be subject to the exclusive jurisdiction of the courts situated at Chandigarh only. No other court shall have the jurisdiction to entertain or try any matter concerning this supply tender.

15. Any conditional terms and conditions mentioned by the firm in their covering letter or in the tender documents will not be considered.
