BOX CABINS ALONGWITH TERMS & CONDITIONS**

Sealed tenders are invited in two parts i.e. Technical Bid and Price Bid from the Firms/Companies/Contractors for providing and installation of two nos. Portable Beat Box Cabins (one each at P.G.I. Bus Stop, Sector 12 and Sector 22/17 Bus Stop) as per Technical Specifications mentioned in the terms and conditions and drawing attached as Annexure I for CTU, Chandigarh. The Offer/Price Bid form and detailed terms and conditions of the contract can be obtained from the office of the undersigned on any working day between 9.00 AM to 5.00 PM or download from the websites i.e. chdctu.gov.in and <http://chandigarh.gov.in>. The prospective bidders can also visit office of the CTU during office hours on any working day by contacting General Manager, CTU, Depot No.II/Store Purchase Section, and CTU Admn. Block, Plot No. 701, Industrial Area, Phase I, Chandigarh for any sort of information with respect to Tender. The envelope containing the Technical Bid should comprise of Earnest Money Deposit (EMD), signed terms and conditions and another envelope of the Price Bid should contain rate offered. These two bids i.e Technical and Price Bid should be sealed in separate covers.

1. Tenderers are required to quote their rate for Two Beat Box Cabins including all taxes (complete job as per Technical Specifications mentioned in the terms and conditions and drawing attached as Annexure I).
2. Tenderer should accompany a cross demand draft for Rs. 10,000/- (Rupees Ten Thousand only) as Earnest Money Deposit (EMD) through bank draft drawn on any scheduled bank at Chandigarh in favour of Divisional Manager, CTU & Director Transport, UT, Chandigarh. Tender received without requisite Earnest Money Deposit (EMD) shall not be considered and rejected out-rightly.
3. The tenders in sealed cover super scribed “**Tender for Providing and Installation of Beat Box Cabins for CTU, Chandigarh**” should be sent only by registered post or submitted in the office of Divisional Manager, CTU & Director Transport, UT, 701, Industrial Area, Phase-I, Chandigarh by hand so as to reach on or before **27.04.2016 at 2.00 PM.** The Technical Bid containing EMD and signed terms and conditions shall be opened on the same day at 3.00 PM in the presence of the tenderers who may wish to attend in the office room of the Divisional Manager, CTU & Director Transport, U.T., Chandigarh. The Offer / Price Bid will only be opened of those tenderers who technically qualify in the evaluation of their technical bids. For opening Offer/Price Bid time and date will be intimated separately. The tenders received after the stipulated date and time shall not be entertained/opened.

4. The Offer/Price Bid form and detailed terms and conditions of the contract can be obtained from the office of the Divisional Manager, CTU & Director Transport, U.T., Chandigarh on any working day between 9.00 AM to 5.00 PM or download from the website of this Undertaking i.e. chdctu.gov.in and website of the Chandigarh Administration i.e. <http://chandigarh.gov.in>.

GENERAL TERMS AND CONDITIONS

1. The rates quoted should be F.O.R. destination i.e. PGI Bus Stop, Sector 12 and Bus Stop, Sector 22/17, Chandigarh or the place designated by this office, specifically mentioned and it must include all taxes/ freight charges (complete job as per Technical Specifications and drawing attached as Annexure I).

(ii) The prospective bidders shall quote the rates as per the detail of infrastructure given in Drawing as Annexure I.

2. Tender/Bid shall be valid for 90 days from the date of issue of rate acceptance letter.

4. Technical Specifications for Beat Box Cabins:

Providing and installation of Portable Beat Box Cabin as approved of size 1800 X 1500 X 2600 – 2500 mm made of 50 mm thick wall, 30/70 mm corrugated roof and 50 mm thick floor of PPGI sheet of approved shade having minimum 0.45 mm thick (TCT) on both sides filled with PUF of density 40 ± 2 kg/cum. The PPGI sheet shall have zinc coating of minimum 120 gsm as per IS 277:1977. The roof will be projected on all sides filled with 30 mm thick PUF insulation on one side and 70 mm in other side to give slope. The floor should be 50 mm thick and will be provided with 2.0 mm thick PVC sheet flooring over wooden ply 6 mm. All the assembly is fixed with MS rolled sections and MS hollow section of required shape and required thickness for frame work of security post. The beat box will have minimum size 770 X 770 mm open able glass windows on both left and right sides with float glass and with Aluminum chain link . The front side is provided with 4 mm thick glass open able

window double shutter of minimum 802 X 802 mm and back side should have 800 X 2100 mm door shutter with 400 X 600 mm window fixed glass 4 mm thick float glass with Aluminum chain link. The window should have sun shade made up of PPFI sheet 0.45 mm thick with minimum 150 mm projection. All the windows and door be provided with fitting of matching shade. The beat box will have one point with multidirectional cabin fan 300 mm (roof mounted) and one light point with 15 watt LED Bulb including pin type lamp with 1.5 sq mm FRSL wire. The security post will be assembled at factory premises. The said Beat Box will be provided with working shelf of suitable material and strength as per approval of C.T.U. After fabrication of said Beat Box Cabin the successful bidder will intimate CTU for its inspection at factory premises, if required. The successful bidder will submit the test certificates of PUF density, thickness of PPGL sheet used and density of sheet. The CTU will be at its liberty to take random sample of the material used for fabrication of said Beat Boxes after visiting factory premises and get it tested at its own cost if required.

5. The successful bidder (Firms/Companies/Contractor) is liable to provide/install the Beat Box Cabins within 15 (fifteen) days from the date of issue of rate acceptance letter/other new allotment of work later on in addition to above said two Beat Box Cabins. In case, the successful bidder backs out, the Earnest Money Deposit shall be forfeited and the bidder shall be black listed for any future contract as per Chandigarh Administration, Finance Department Notification No. 1927- F&PO(3)-2009/1170 dated 27.2.2009.

6. The work shall start immediately from the date of issuance of work order. Providing/Installation to be done within 15 (fifteen) days of placing the work order failing which penalty of 1% of the total contract value per week will be imposed.

7. Performance Security:

The successful bidder will have to deposit performance security @ 5% of the total cost of the Beat Box Cabins for CTU in the form of Fixed Deposited Receipt (FDR) from a commercial bank or a Bank Guarantee in favour of "Director Transport U.T., Chandigarh" which should be valid for a period of 27(Twenty Seven) months from the date of supply order and will have to be deposited within 15 days from the date of issue of the Letter of Acceptance/Supply Order.

8. Warranty

Warranty of the Beat Box Cabins should be two years from the date of installation of Beat Box.

9. The successful bidder (firms/Companies/Contractor) is liable to maintain the Beat Box in good condition and attend the call of the department immediately for any type of repair/defect during guarantee/warranty period immediately without charges any amount in this regard.

10. **Arbitrator:** In case of a dispute arising between the parties with regard to interpretation of these terms and Agreement or their fulfillment, the dispute shall be referred to the Secretary Transport, Chandigarh for arbitration, who will be sole Arbitrator and whose decision shall be final and binding on both the parties.

The CTU and the supplier or his nominee both agree to accept the Sole Arbitrator. Further no party shall have the right to go to the court of law for any dispute under this agreement for their fulfilment unless the dispute is first referred to the Sole Arbitrator specified under the Agreement.

11. **Jurisdiction:** Any dispute or difference or claim etc, shall be subject to the exclusive jurisdiction of the courts situated at Chandigarh only. No other court shall have the jurisdiction to entertain or try any matter concerning this supply tender.

12. Any conditional terms and conditions mentioned by the firm in their covering letter or in the tender documents will not be considered

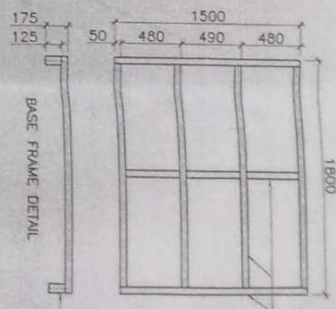
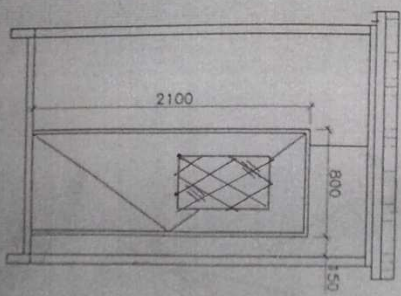
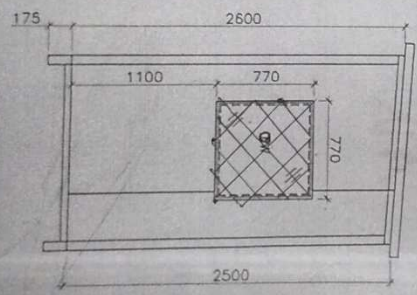
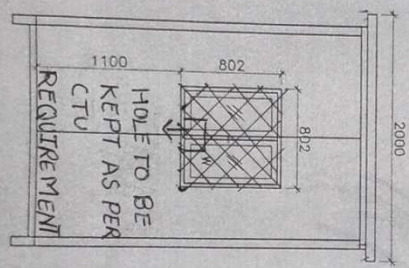
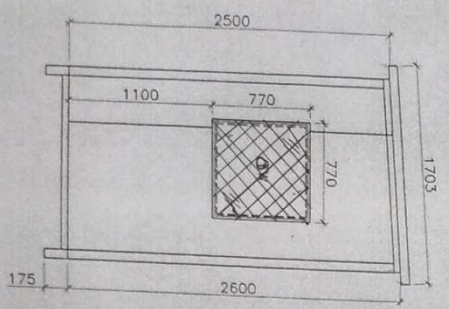


DOOR EQUIPPED WITH LOCKING ARRANGEMENT
