## TERMS AND CONDITIONS FOR THE SUPPLY OF WASHING MACHINE AND TYRE CHANGING MACHINE

- 1. The rates quoted should be F.O.R. destination i.e. Workshop of CTU Depot No.II, Industrial Area, Phase I, Chandigarh or the place designated by this office, specifically mentioned and it must include installation of the machines.
- 2. In case of authorized dealers/distributors they must attach the Certificate of dealership issued by the Company/Manufacturer for which the machine is to be supplied. Tender received without authorization Certificate of concerned company shall not be considered and rejected out-rightly.
- 3. The Bus Washing Machine should be adjustable/capable of washing all type of buses i.e. Mini/Midi to 12 Meter buses. Similarly in case Tyre Changing Machine, the same is capable to open the tyres 7.50 x 16 to 1000 x 20 or latest.
- 4. Incomplete/conditional bid will not be entertained.
- 5. The offer of tender will be valid for a period of 180 days from the date of opening of tender. Withdrawal of offer of finalized firm during this period will result into forfeiture of earnest money.
- 6. Payment will be made against physical delivery and after successfully installation and operation of washing machine/Tyre Changing Machine (as the case may be) in the CTU Workshop, Depot No. II.
