## Technical Bid

### ANNEXURE 'A'

#### **OTHER TERMS & CONDITIONS FOR SUBMITTING TENDER FOR SUPPLY OF PRECURED TREAD RUBBER AND ALLIED MATERIAL. FOR RETREADING OF TYRE SIZES 9.00X20 AND 10.00X20.**

1. Place of Delivery Destination Chandigarh Transport Undertaking (Door Delivery)
  2. Excise Duty Inclusive (as applicable)
  3. Sales Tax/VAT Inclusive (As applicable to Govt. Dept. /STUs)
  4. Packing and Forwarding Inclusive & Securely packed.
  5. Specifications As per the latest ASRTU specifications.
  6. Validity of Offer The offer should be valid for six months (180 days) from the date of opening of financial bid.
  7. Validity of Contract The validity of contract will be for one year from the date of decision issuing rate acceptance letter/first Supply Order.
  8. Quantity The quantity mentioned in the tender is approximate and can be increased / decreased upto 25% of normal quantity as per requirement of the Undertaking during the validity period of the offer on the same rates and terms & conditions.
  9. Precured process
    - 1<sup>st</sup>. Resoling Mileage Guarantee Minimum 38000 Kms/tyre.
    - 2<sup>nd</sup>. Resoling Minimum 32000 Kms/tyre.
    - 3<sup>rd</sup>. Resoling Minimum 28000 kms/tyre.
- The assessment of recovery on account of less kilometers/mileage covered by resoled tyres retreated with the tread rubber supplied by the firm than the guaranteed kilometers/Mileage and pre-maturely failed resoled tyres will be made on quarterly basis taken all the retreaded tyres mileage together and the recovery on account of deficiency if any, will be recovered from the supplier.
10. Performance Bank Guarantee/Security 5 % of the total value of order valid for 15 months from the date of supply order.
  11. Risk Purchase In case of Non - supply of material as per delivery schedule, the stores will be purchased of the same specifications, terms & conditions from other sources at the risk and cost of the firm. The excess cost thus incurred will be recovered from the supplier from his pending bills /EMD / BG / through legal action. The procedure of risk and cost purchase will be adopted after serving registered notice to supply stores within 30 days.

12. Standard Consumption      Precured process rubber base (i) width 187mm, weight 9.5kg/tyre, (ii) width 197mm, weight 10 kg/tyre, (iii) width 205 mm, weight 11.5 kg/tyre. The rolls should be supplied in the whole multiples of above said standard consumptions of tread rubber as per requirement
13. Test      Two random samples of tread rubber and other allied material every four months are liable to be tested at CIRT, Pune or any other NABL accredited test house/laboratory. In case of the random sample failing in the testing, penalty as per ASRTU criteria will be imposed on the firm, which will be recovered from current bills.
14. Payment terms      Strictly as per ASRTU terms & conditions
15. Delay Penalty      Delay consignment / delivery schedule will be subjected to 1% penalty per consignment per month of delay or part thereof recoverable on the value of store not supplied.
16. In case bidder withdraws its offer within the validity period, submit forged/fake documents or do any unethical/un-business like activity, do not accept the supply order, do not supply 1<sup>st</sup>.delivery schedule/do not submit Bank Guarantee, EMD of the firm will be forfeited and other departmental penal action, as deemed fit, will be taken.
17. The department reserves the right to modify/revoke the order/agreement at any point of time without assigning any reason.
18. Any conditional terms and conditions mentioned by the firm in their covering letter or in the tender documents will not be considered.
19. The firm will have to supply the evidence of Excise Duty paid along with each invoice, if any.
20. Confirmation of supply of 25% extra quantity during the contract period on the same rate and terms and conditions, if required by the department.
21. The tender should be submitted along with a copy of the latest test reports which are issued within one year by CIRT Pune or any other NABL accredited testing laboratory for tread rubber and other allied material and credentials of supplying to other STU's/Govt. Departments during 3 preceding years.
22. Tender documents should be duly paged and the relevant documents enclosed should be duly signed and stamped by the authorized representative of firm.
23. Firm should have capability to supply tendered quantities.
24. The firm has to furnish an affidavit along with the tender documents. "That the firm has not been black listed or debarred in the past from doing any business in this field in any state transport/undertaking/any Govt. organization/ PSUs or any Govt. agencies in India".
25. The tenders submitted directly by the manufacturers meeting eligibility criteria to quote the rates for tread rubber and allied materials for precured retreading material will only be considered. The supply will be accepted directly from the manufacturers only.

26. Arbitrator : All disputes and differences arising out of or concerning what so ever shall be referred to the sole Arbitrator or an officer appointed by Secretary Transport, Chandigarh Administration, Chandigarh acting as such at the time of the reference. There will be no objection to such appointment, that the Arbitrator so appointed is a Govt. servant that he has to deal with such matters in the course of duties as Govt. servant and might have expressed views on all or any of the matters in disputes or differences. The award of such Arbitrator shall be final and binding on, the parties involved. The Arbitrator has the power to extend the time for making the award on request from either of the parties.

27. Jurisdiction : Any dispute or difference or claim etc, shall be subject to the exclusive jurisdiction of the courts situated at Chandigarh only. No other court shall have the jurisdiction to entertain or try any matter concerning this supply tender.
