The remaining security, if any, will be refunded to the licensee after he hands over the vacant possession of the premises to the Director Transport, U.T., Chandigarh on the expiry of the license period.
- 6. The licensee shall not display any material which may be considered objectionable by the Divisional Manager, CTU & Director Transport U.T., Chandigarh.

- 7. The fixation and removal of the advertisement boards will be done by the licensee at his own cost. Electronic wiring will also be done by the licensee at his own cost in a proper manner. But the license fee shall be charged from the date of commencement of this license.
- 8. The licensee shall not be entitled to claim any compensation on account of any interruption in the display of advertisement board/hoarding due to breakdown of electricity or any other unavoidable circumstances.
- 9. The licensee shall not make any addition or alteration in the premises without the consent/approval of the Divisional Manager CTU & Director Transport, UT., Chandigarh.
- 10. The licensee shall not directly or indirectly sublet the contract to any other person/firm in any manner.
- 11. The licensee shall not use the premises at the ISBT, Sector-17, Chandigarh for the purpose other than for which license has been given.
- 12. The licensee shall not allow to use the electricity for the displaying the advertisement sign boards at the ISBT, Sector-17, Chandigarh without prior approval of the Divisional Manager CTU & Director Transport, UT., Chandigarh and in case, the licensee make use of electricity for the displaying the advertisement sign board, the licensee shall install the electricity meter at his own from the electricity department within 15 days from the date of the award of the contract and till the installation of electricity meter, he will pay the electricity charges @ Rs. 6/- per unit or as fixed by the department.
- 13. The licensee shall pay all the Central, State and local taxes/fees for the time being imposed or assessed by the Competent Authority or levied in future from time to time including payment of stamp duty and or registration fee prescribed by the Competent Authority on the registration of License/ Agreement deed.
- 14. The licensee shall obtain all the required permissions/license from concerned authorities for displaying the advertisement at his own level and shall obey all the rules/regulations applicable from time to time in this regard.
- 15. The successful venders shall be furnished his particulars to the Inspector General of Police, UT, Chandigarh for his verification of antecedents and the same shall be furnished to the licensor after verification.
- 16. The licensee shall at all the times without any hindrance, permit the duly authorized officers, servants of the Govt. to enter into and upon the premises for the purpose of inspection and enforcing all the terms and conditions of this license.
- 17. The licensee will indemnify the Chandigarh Transport Undertaking and keep it harmless from all claims, demands, action, cause and charges to which the Chandigarh Transport Undertaking may become liable or which it may have to pay or be held liable thereof by any reason including the reason of injury to any person, reputation or property suffered or sustained by any employee of the Chandigarh Transport Undertaking or arising out of any activity or negligence or commission of the licensee or its employees.
- 18. In case the area of operation is increased/decreased, the license fee can be accordingly increased or decreased by the Director Transport, U.T., Chandigarh.

- 19. The licensee shall be responsible to protect the Govt. property in his/her possession during the licence period from any damage or loss. If there is any damage caused to CTU property, personnel and reputation due to any action of the licensee or personnel hired by him, a penalty to the maximum amount of Rs.1,00,000/- (Rupees: One lakh) can be imposed, however due notice and opportunity of hearing shall be given before imposing such penalty by the licensor.
- 20. The licensee will be required to sign an agreement within the times specified by the Director Transport, UT, Chandigarh containing the detailed terms and conditions in addition to the above conditions.
- 21. The licensor shall be at liberty to terminate the license by giving 15 days clear notice in writing to that effect.
- 22. The licensor reserves the right to impose the penalty/fine on breach of any of the terms and conditions of the license.
- 23. In case of breach of any of the terms and conditions of this deed by the licensee, the licensor may terminate the license by giving 15 days clear notice and grant the license to other party at the risk of licensee and recover the loss if any caused to the licensor.
- 24. On the termination of the license in accordance with Clause 19 above, the licensor may in addition to resumption of the premises, forfeit the whole or part of the security along with interest thereupon deposited by the licensee.
- 25. The licensee may terminate the license deed by giving 30 days clear notice in writing.
- 26. The licensee shall deliver the vacant possession of the premises to the Divisional Manager CTU & Director Transport, UT., Chandigarh on the expiry or termination of the license.
- The tenderer shall also submit an affidavit on Non Judicial Stamp papers of Rs. 15/- duly attested by the notary public or magistrate indicating that no criminal proceeding is pending against him/firm/company anywhere in India and they have no dues/outstanding against any of the Central/state government/organization/boards/cooperation.
- 28. The tenderer also submit an undertaking indicating that he/she/they/firm/ company have not been debarred/blacklisted by the department of government of India or any state government or any union territory or any public undertaking/body.
- 29. All disputes or differences arising out or in any way touching or concerning the deed whatsoever shall be referred to the sole Arbitration of the Secretary Transport, Chandigarh Administration, acting as such at the time of reference. There will be no objection to such an appointment that Arbitrator so appointed is a Govt. servant and that he had to deal with matters to which the agreement relates and that in the course of these duties as such the Govt. Servant has expressed views on all or any of the matters in dispute or difference. The award of such Arbitrator shall be final and binding on the parties to the agreement.

30. Subject to the aforesaid, the Arbitration Act, the Rules made there under, any modification for the time being in force shall be deemed in apply to the Arbitration proceedings.
