The Shops/Chef (Restaurant)/Fast Food Center (Ground Floor) at ISBT, Sector 43 can also be inspected by the bidders during office hours on any working day by contacting General Manager, CTU-II, Assistant Controller (F&A), Station Supervisor, ISBT 43, Care Taker (Bus Stand) Chandigarh. The bidders are advised to inspect the premises and only after inspection, they may quote their rates.

1) Eligibility Criteria

E-bids are invited for trade/activity as mentioned against the said shops. The Tenders are invited under Double Envelop System i.e. Technical and Financial Bid separately. No extra facility will be provided at any later stage can also be inspected by the bidders during office hours on any working day by contacting General Manager, CTU – II/Assistant Controller (F&A)/ Station Supervisor, ISBT-43/Care Taker (Bus Stand) Chandigarh. The bidders are advised to inspect the premises and only after inspection, they may quote their rates. The terms and conditions will be as under:-

- 1. The license shall be for a period of six years with an annual increase of 10% in the license fee from the date mentioned in the allotment letter by the Chandigarh Transport Undertaking, Chandigarh.
- 2. The e-Tender must be accompanied by the scanned copy of Demand Draft/Banker Cheque of an earnest money of Rs. 1,00,000/- (Rupees One Lakh only) of any Scheduled Bank drawn on favour of Director Transport, UT, Chandigarh, Plot No. 701, Industrial Area, Phase I, Chandigarh. Original Demand Draft/Banker Cheque should be physically submitted by the tenderer before the time of downloading of technical bid to office of Director Transport. Earnest money shall not be accepted through cheque. Any amount lying with the CTU on any other account will not be allowed to be adjusted against the EMD for the present tender.
- 3. Conditional/telegraphic tender/tender received through fax, tenders without earnest money and receiving after due date and time and submitted not on the prescribed form shall not be entertained.
- 4. e-Tender are to submitted under two ways tendering process i.e. Technical Bid and Financial Bid separately. After scrutiny of the information received in Technical Bid, clarifications, if any, where ever necessary, will be obtained from the party. The Director Transport reserves the right also to inspect the existing shop being run by the tenderer as part of the Technical Bid analysis. After necessary appraisal of the party's experience and technical expertise, technical short-listing will be done. Consequently, "Financial Bid will be opened in respect of only those tenderers who are found technically suitable based upon assessment made of credentials etc of the tenderer.
- 5. The licensee shall regularly pay the monthly license fee in advance on or before the 10th day of every month (if 10th happen to be holiday than next working day will be due date) to the Director Transport, UT., Chandigarh failing which a penalty at the rate of 1% of the outstanding license fee per day will be imposed till the license fee is paid.
- 6. In addition to the monthly licence fee, the licencee shall pay the electricity charges by installing the electricity meter on his own. Licencee will also pay the water charges as fixed by the Director Transport, UT., Chandigarh and also liable to pay any enhancement in the tariff by Electricity Department/Municipal Corporation during the currency of contract.
- The bidder shall furnish Earnest Money Deposit (EMD) of Rs. 1,00,000/- (Rupees 7. In case, the successful bidder backs out, the Earnest Money Deposit shall be forfeited and the bidder shall be black listed for anv future contract. Further. the individuals/Banks/Multinational Companies/Institutions/firms will be liable to be blacklisted as per Chandigarh Administration, Finance Department Notification No. 1927-F&PO (3)-2009 dated 27.02.2009 including following types of situation:-

- i) Dishonest/Fraudulent/Sharp practices are indulged in by the party.
- ii) Advancing a claim on the basis of forged documents.
- iii) Sale or supply of spurious items and providing public safety.
- iv) Material concealments/suppression of facts or gross misrepresentation of facts.
- v) Any other case or situation involving National Security.
- 8. The bidder should have minimum turnover of Rs. 50.00 lac (Rupees Fifty lakh only) in the case of Chef (Restaurant) and Fast Food Center (Ground Floor) (copy of which should be attached) in same trade duly attested by C.A.
 - i) The licensee has to ensure that the vending machines for tea/coffee/cold drinks etc. should be properly installed and maintained in a hygienic manner.
 - The licensee shall be responsible for providing comfortable seating arrangements with aesthetic looks and pleasing ambience.
 One base meal/beverage will be provided by each licensee at the affordable rate for the common man.
 - iii) The licensee should have Food licence certificate from the competent authority in respect of existing business.

The tender without these documents shall liable to be rejected straightway.

- 9. The licensee, at the time of execution of the agreement/licence deed, shall furnish a security deposit equal to four months licence fee in the form of Fixed Deposit Receipt (FDR) from any scheduled bank at Chandigarh duly pledged in favour of the Director Transport, UT., Chandigarh with validity of 75 (Seventy Five) months. The security amount of shops shall be increased correspondingly with increase in rent every next year and the increased amount be deposited on or before the start of the every next year during the contract period. In the event of breach or non-observance of any of the terms and conditions of this licence deed the Director Transport, U.T; Chandigarh may forfeit the security either in full or in part. The remaining security, if any, will be refunded to the licensee after he hands over the vacant possession of the premises to the Director Transport, U.T., Chandigarh on the expiry of the licence period.
- 10. The licencee shall take possession of the premises after the grant of license at his own cost. But the license fee shall be charged from the date of physical possession of the sites/premises of this license.
- 11. The licencee shall not make any addition or alternation in the premises without the consent/approval of the Director Transport, U.T., Chandigarh.
- 12. The licencee shall not directly or indirectly sublet the contract to any other person/firm in any manner.
- 13. The licensee shall be responsible to protect the Govt. property in his/her possession during the license period from any damage or loss and shall be responsible for maintaining perfect cleanliness in and around the premises. The Licensee shall pay for damage done by him/her or his/her servants or agents during the period of license to the property of the licensor.
- 14. The licensee shall install electricity meter at his own level from electricity department and intimate to this office after installation of electricity meter. The security deposited by the licensee with the Chandigarh Transport Undertaking shall be released after producing the "No Due Certification" (NDC) from the Electricity Department in respect of payment of electricity bills of the premises.
- 15. The licensee shall not use the premises at the ISBT, Sector 43, Chandigarh for the purpose other than for which license has been given. The list of rates of the articles to be sold by the licensee in the Restaurant/Fast Food Center shall be displayed in the premises as duly approved by the Department.
- 16. The list of rates of the articles to be sold by the licensee in the shops shall be displayed in the premises as duly approved by the Department. The rates of items to be sold in the Shops/Chef (Restaurant)/Fast Food Center (Ground Floor) will be fixed rates. The rates should not be charged above MRP and the same shall be increased/decreased in consultation with the Director Transport, U.T., Chandigarh.

- 17. The licensee shall pay all the Central, State and local taxes for the time being imposed or assessed by the Competent Authority or levied in future from time to time including payment of stamp duty and or registration fee prescribed by the Competent Authority on the registration of Licence/Agreement deed.
- 18. The licencee shall obtain all the required permissions/licence from concerned authorities for running the Office/Sale-cum-Exhibition/Rooms/Cabins at his own level and shall obey all the rules/regulations applicable from time to time in this regard.
- 19. The licencee shall not be allowed extension of counter/additional space in any circumstances.
- 20. The licencee shall ensure good behaviour of his employees with the public.
- 21. The particulars of successful venders shall be furnished to the Inspector General of Police, UT, Chandigarh for their verification of antecedents.
- 22. The Director Transport, UT., Chandigarh can allot any number of Shops/Chef (Restaurant)/Fast Food Center (Ground Floor) at ISBT, Sector 43, Chandigarh.
- 23. No obnoxious trade shall be carried on in the premises.
- 24. Children below 14 years of age will not be employed under any circumstances.
- 25. The licensee shall not allow any hawker to sell groundnut or any other eatable items or unhygienic commodities in the allotted premises.
- 26. No servants of any commercial establishments should be allowed to reside at the allotted site at night.
- 27. The licencee shall also provide the drinking water taps/electric fittings and in case these taps/fitting go out of order, shall replace the same immediately.
- 28. The licensee shall only be allowed to use cooking gas for cooking. Proper outlet for smoke through latest type of chimneys will be made by the licensee.
- 29. The licencee shall at all the times without any hindrance, permit the duly authorized officers, servants of the Govt. to enter into and upon the premises for the purpose of inspection and enforcing all the terms and conditions of this licence.
- 30. The licensor shall be at liberty to terminate the licence by giving 30 days clear notice in writing to that effect.
- 31. The licensor reserves the right to impose the penalty/fine on breach of any of the terms and conditions of the licence.
- 32. In case of breach of any of the terms and conditions of this deed by the licencee, the licensor may terminate the licence by giving 30 days clear notice and grant the licence to other party at the risk of licencee and recover the loss if any casued to the licensor.
- 33. On the termination of the licence in accordance with Clause 32 above, the licensor may in addition to resumption of the premises, forfeit the whole or part of the security deposited by the licencee.
- 34. The licencee may terminate the licence deed by giving 30 days clear notice in writing. The loss thus caused to Department on re-allotment of the contract of the premises shall be borne by the licencee.

- 35. The licensee shall deliver the vacant possession of the premises to the Director Transport, UT., Chandigarh on the expiry or termination of the license.
- 36. All disputes or differences arising out or in any way touching or concerning the deed whatsoever shall be referred to the sole Arbitration of the Secretary Transport, Chandigarh Administration, acting as such at the time of reference. There will be no objection to such an appointment that Arbitrator so appointed is a Govt. servant and that he had to deal with matters to which the agreement relates and that in the course of these duties as such the Govt. Servant has expressed views on all or any of the matters in dispute or difference. The award of such Arbitrator shall be final and binding on the parties to the agreement.
- 37. Subject to the aforesaid, the Arbitration Act, the Rules made there under, any modification for the time being in force shall be deemed in apply to the Arbitration proceedings.
- 38. The licensee will indemnity the Chandigarh Transport Undertaking and keep it harmless from all claims, demands, action, cause and charges to which the Chandigarh Transport Undertaking may become liable or which it may have to pay or be held liable thereof by any reason including the reason of injury to any person, reputation or property suffered or sustained by any employee of the Chandigarh Transport Undertaking or arising out of any activity or negligence or commission of the licensee or its employees.
- 39. That the Director Transport, UT., Chandigarh shall have a lien on all the belongings and properties of the licensee for the time being in or upon the premises.
- 40. In case the area of operation is increased/decreased, the license fee can be accordingly increased of decreased by the Director Transport, U.T., Chandigarh.
- 41. The Licensee shall submit a passport size photograph along with specimen signatures duly attested by Gazetted Officer or Notary Public. He will also submit the proof of residence.
- 42. The licensee will be required to sign an agreement within the times specified by the Director Transport, U.T., Chandigarh containing the detailed terms and conditions in addition to the above conditions.
- 43. On the termination of license under any of terms and conditions of the license:i) The Licensee will deliver the vacant possession of the shop in its original state to the licensor, failing which the shop shall be got vacated in accordance with the provisions contained in the Public Premises (Eviction of unauthorized Occupants) Act, 1971. The cost of damages, if any, to the premises or fixtures shall be recovered from the licensee.
 ii) The amount of security lying at the credit of the licensee after adjusting all the dues
