- 26. The licensee will indemnity the Chandigarh Transport Undertaking and keep it harmless from all claims, demands, action, cause and charges to which the Chandigarh Transport Undertaking may become liable or which it may have to pay or be held liable thereof by any reason including the reason of injury to any person, reputation or property suffered or sustained by any employee of the Chandigarh Transport Undertaking or arising out of any activity or negligence or commission of the licensee or its employees.

- 35. The licensee shall not use any electric appliance or any such other appliance without the prior permission and approval in writing of the Divisional Manager CTU & Director Transport, U.T, Chandigarh.
- 36. It shall be the responsibility of the licencee to keep the space/building neat and clean, expenditure on the repair/renovation, if required during the period of licencee shall be borne by the licencee.

#### PENALITIES/TERMINATION OF CONTRACT.

- 37. The licensor reserves the right to impose the penalty/fine on breach of any of the terms and conditions of the licence upto the maximum of Rs. 20,000/-.
- 38. In case of breach of any of the terms and conditions of this deed by the licencee, the licensor may terminate the licence by giving 15 days clear notice and grant the licence to other party at the risk of licencee and recover the loss if any caused to the licensor.
- 39. The licensor shall be at liberty to terminate the licence by giving 15 days clear notice in writing to that effect.

- 40. On the termination of the licence in accordance with the Clauses of terms and conditions of this licence, the licensor may in addition to resumption of the premises, forfeit the whole or part of the security deposited by the licensee along with interest thereupon.
- 41. The licencee may terminate the licence deed by giving 30 days clear notice in writing. The loss thus caused to Department on re-allotment of the contract of the premises shall be borne by the licencee.
- 42. The licensee shall deliver the vacant possession of the premises in original state to the Director Transport, UT., Chandigarh on the expiry or termination of the license.
- 43. On the termination of license under any of terms and conditions of the license:

#### **ARBITRATION**

- 44. All disputes or differences arising out or in any way touching or concerning the deed whatsoever shall be referred to the sole Arbitration of the Secretary Transport, Chandigarh Administration, acting as such at the time of reference. There will be no objection to such an appointment that Arbitrator so appointed is a Govt. servant and that he had to deal with matters to which the agreement relates and that in the course of these duties as such the Govt. Servant has expressed views on all or any of the matters in dispute or difference. The award of such Arbitrator shall be final and binding on the parties to the agreement.
- 45. Subject to the aforesaid, the Arbitration Act, the Rules made there under, any modification for the time being in force shall be deemed in apply to the Arbitration proceedings.

#### 46. **JURISDICTION**

Any dispute or differences or claim etc shall be subject to the exclusive jurisdiction of the Hon'ble Courts situated at Chandigarh only. No other Court shall have the jurisdiction to entertain or try any matter concerning this tender.

### (C) <u>IN ADDITION TO ABOVE, THE FOLLOWING TERMS AND CONDITIONS ARE ALSO APPLICABLE FOR FOOD COURT-I ONLY:-</u>

- 1. The rates of the articles to be sold in the premises shall be got approved by the licensee from the Director Transport, U.T. Chandigarh and the same shall be displayed in the premises as duly approved by the Department.
- 2. The licensee shall only be allowed to use cooking gas for cooking. Proper outlet for smoke through latest type of chimneys will only be made by the licensee.

The rates shall be reasonable and the rates should not be charged above fixed rate or MRP in any manner and the same shall be increased or decreased in consultation with the Director Transport, U.T., Chandigarh.
- 4. The licencee shall obtain all the required permissions/licence from concerned authorities for running the business at the premises at his own level and shall obey all the rules/regulations applicable from time to time in this regard.

- 5. The bidder should have minimum experience of two years (out of last five years preceding the year 2018-19 in the relevant field of running food outlets i.e. as the same trade as the food court (copy of which as proof of experience alongwith work satisfactory certificate should be attached).
