In case, the successful bidder backs out or failed to do the job, the Earnest Money Deposit/security shall be forfeited and the bidder shall be black listed for any future contract as per Chandigarh Administration, Finance Department Notification No. 1927-F&PO(3)-2009/1170, dated 27.2.2009 on the following types of situations:-	The successful bidder (firms/Companies) is liable to install complete system as defined in BoQ along with its allied equipment (Complete job) within 90 days from the date of issue of Letter of Award, if the delay on supply, installation and commissioning of the PIS Board is attribute to the successful bidder then the penalty @0.15 % per day per PIS board of CAPEX cost will be imposed, however maximum penalty shall be 10% (ten) of the total CAPEX cost.  In case, the successful bidder backs out or failed to do the job, the Earnest Money Deposit/security shall be forfeited and the bidder shall be black listed for any future contract as per Chandigarh Administration, Finance Department Notification No. 1927- F&PO(3)-2009/1170, dated 27.2.2009 on the following types of situations:-
